## Uptown Alliance Communication Mayor's Budget

Uptown and Queen Anne stakeholders:

Mayor Mike McGinn's proposed budget cuts include items that would greatly reduce our ability to communicate with and work with City Government. Our ability to deal with our community affairs would be impacted.

- The Magnolia Neighborhood Service Center would close as of Jan. 1, 2011. The Coordinator position held currently by Christa Dumpys would be cut.
- The staffing for the Magnolia/Queen Anne District Council would be jeopardized.
- The hours of operation of the Queen Anne Community Center would be curtailed. This may make meetings much more difficult to schedule at this location.
- The gymnasium at the Community Center would be re-assigned to BIZKIDS, a non-profit production company.
- The Neighborhood Matching Grant funds would be cut by \$700,000. (See special public comment opportunity, 9:30am, Oct. 5, noted at end of this e-mail.)

Queen Anne appears to have been targeted for cuts more than other neighborhoods.

You can make your voice heard on these proposed cuts. The City Council will hold three Budget Hearings (Community Meetings.)
These are traditionally crowded affairs packed with special interest appeals - many from low-cost housing advocates and feeding services.
So, arrive early, well before 5pm, in order to be on the sign-up sheet before late evening.

The City Council can rescind cuts, but must balance the budget against projected revenues.

No one will speak up for Queen Anne and Uptown but us, the stakeholders. Please consider attending one or more of the Community Meetings listed below.
